The cancellation is premised on the following reason(s):

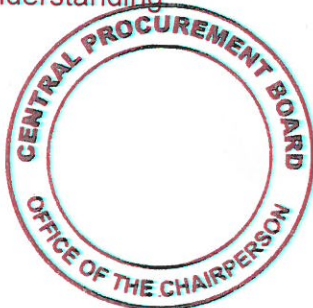
- a) That the first bidder (Bidder:1), submitted a Tax Certificate dating back to 2016 which contravenes the requirements of a Valid Good Standing Tax Certificate as set out in ITB 5 of the bidding document,
- b) The second bidder (Bidder:2), did not submit a completed and signed bidding documents as required under ITB 5 of the bidding document;
- c) The third bidder (Bidder:3), submitted a Social Security Certificate that expired on 9 September 2019 which contravenes the requirements of ITB 5 of the bidding document. Additionally, the bidder submitted an Affirmative Action Certificate of a different company.
